Minutes of the proceedings of the Annual Meeting

The annual meeting of Glyndon Township, in the county of Clay and the state of Minnesota was held at 8:00 PM on the 8th day of March 2022. The meeting was called to order by Virginia Moon.

A motion to elect Kevin Nelson as moderator was made by Virginia Moon and seconded by John Winter. The motion passed.

Members present included: John Winter, Kevin Nelson, Virginia Moon. Angie and Fred Kuehl attended by zoom.

The minutes from the March 2021 annual meeting were reviewed. John made a motion to approve the minutes, Kevin seconded. Motion carried.

The financial report was reviewed. Fred made a motion to approve, and Kevin seconded. Motion Carried.

Road maintenance was discussed. Kevin and John attended a meeting with the county. The fee will increase next year from \$813-\$\$852 per mile. We compared this to an independent and it is very reasonable. However we will need to work out the issues with are having with the washboard grading and no snow removal on weekends. We will have County rep Justin and County Commissioner Frank come to our next meeting and see if we can resolve the issues before taking other action. Jake Pender and other representatives from Riverton will also be joining us.

The proposal from L&M was discussed for mowing and spraying the ditches. A motion was made by Fred and seconded by Kevin to accept the proposal. Motion carried.

The annual election for Supervisor was Fred Kuehl taking the majority of votes. He will start a new 3-year term. Kevin made a motion to accept the results, Virginia seconded. Motion carried.

The 2022 was presented and reviewed. The tax levy will remain the same with 25,000 set for road and bridge,15,000 for the general fund, \$7,000 for fire, 250 for gopher bounty, and 500 for weed. Virginia made a motion to approve the budget and Angie seconded. Motion carried.

A motion was made by Angie to continue with Bell State Bank of Dilworth as our depository, Hawley Herald as our official paper for notices that can't be posted on our website. Kevin seconded and the motion carried.

A motion by Fred and seconded by Kevin will keep the gopher bounty at \$4,00.

Kevin made a motion to accept the IRS mileage reimbursement of 58.5 cents. Fred seconded. Motion carried.

Kevin made a motion to raise the Election Judges pay to \$21.00 per hour but leave all other salaries the same. John seconded. Motion carried.

The next annual meeting will be March 14, 2023, with March 21st being the backup date.

Fred made a motion to adjourn the meeting. Angle seconded. The meeting adjourned at 8:25 PM.
