APRIL, 11TH 2023, MONTHLY MEETING

Meeting Minutes:

Members present were Fred Kuehl, Kevin Nelson, John Winter, Angue Kuehl, and Justin Thompson. Fred called the meeting to order at 7:00PM.

The minutes from the March meeting were read and approved. John made a motion to accept and Kevin seconded. The minutes were accepted.

The treasurer's reports (Balance Sheet and Profit Loss YTD Comparison) were reviewed and signed by the supervisors.

Old Business:

Discussion was held on ARPA recovery money and ways that we want to spend these funds with their funds. Angie discussed using the money for data devices (cell phone or tablet) for each of the members. Angie was going to check on the price for these devices. John and Kevin stated they weren't sure they wanted another device for township business.

ARPA reporting needs to be filled out by the end of the month. The items were tabled until next month

Discussion was also held on the 12th Avenue bridge. John stated there may not be funding for the bridge. It is part of the bonding bill and has to be approved by Minnesota congress. The money may first go to the country road 79. More discussions to follow.

The following items from the mail were reviewed

- From Clay County Fair Board of Directors:
 - Opportunity to sponsor / help fund the new restroom facility
 - There was a discussion on supporting the fair and this new restroom
 - Fred made a motion to Support the fair with \$1,500 and support the new bathroom with \$1,000. Kevin seconded the motion. The motion passed, Justin will send the checks to the fair boards.

New Business:

Building permits

- Troy Kuehl plans on building a 50x80 Ag storage shed.
 - John made a motion to approve. Fred Seconded the motion. Motion passed

Romantic Moon Road Maintenance 158 80th Street S.

- Roy Gilbertson asked if the township would be able to maintain the road which comes into the property near the railway once a month.
- Fred will talk with Justin Sorum (County Engineer) to see about accomplishing this.
- John Made a motion to approve maintaining this road. Fred Seconded the motion.

Flood Measures information:

- The County Commissioner passed a resolution declaring a State of Emergency due to

- spring flooding. Fred will set out road closure signs when necessary.
- Fred will look into purchasing a few new reflective signs for the township. Old ones are becoming unusable.
- Kevin made a motion to approve purchasing new signs. John Seconded the motion.

Strata Credit Application:

- In order to get gravel from Strata, the township has to fill out their credit application.
- Kevin made a motion to allow Justin to fill out this application. Fred Seconded the motion

Clay County Maintenance Agreement:

- The township has been using Clay County to maintain the township road. The cost for maintenance has increased over the past year. This year the cost to maintain these roads has increased to \$973.00 per mile.
- Kevin made a motion to accept this year's maintenance agreement with Clay County. John seconded the motion.
- Justin will return the maintenance agreement to the county.

Noxious Weeds:

- John brought new information on noxious weed.
- Justin will update the township website with this information.

West Central Regional Water Service:

- A paper was sent out by AE2S showing proposed rural water projects and what progress they have achieved to date. Their mission is to garner more support to expand there projects.
