Meeting Minutes:

Members present were Fred Kuehl, Kevin Nelson, John Winter, Angie Kuehl and Justin Thompson. Fred called the meeting to order at 7:06PM.

The minutes from the June meeting were read and approved. Fred made a motion to accept these minutes, Kevin seconded. The minutes were accepted.

The treasurer's reports (Balance Sheet and Profit Loss YTD Comparison) were reviewed and signed by the supervisors.

Old Business:

Discussion was held on ARPA recovery money and ways that we want to spend these funds. Sheriff Mark Empting joined the meeting and discussed the need for a rapid K-9 deployment device (Hot & Pop) for the department's new vehicle. This device is worn by the deputy to release the dog from the vehicle if the deputy needs assistance from the dog. Sheriff Empting brought a quote for the system which was reviewed by the supervisors. The quote included install. John made a motion to allot \$2,000 of the ARPA funds for the device. Kevin made a motion to approve this budget. The motion passed. Sheriff Mark will let the board know when this device is ready to be purchased by the Township.

The Cam-Am Defender was purchased on 6/21 with the tank. It was discussed the vehicle would be given to the fire department at the next meeting.

Discussion held on the 12th Avenue bridge was again tabled till next month. Justin (with Clay County) is slated to attend next month's meeting.
