Meeting Minutes:

Members present were Fred Kuehl, Kevin Nelson, Angie Kuehl and Justin Thompson. Fred called the meeting to order at 7:03PM.

The minutes from the September meeting were read and approved. Fred made a motion to accept these minutes, Kevin seconded. The minutes were accepted.

The treasurer's reports (Balance Sheet and Profit Loss YTD Comparison) were reviewed and signed by the supervisors.

Old Business:

Discussion was held on ARPA recovery money. There is a remaining amount of \$1,180.94. There was a discussion on donating the remaining money to UC Hope. Fred made a motion to donate the remaining ARPA money to UC Hope. Kevin seconded the motion. The motion passed. Angie will deliver the check to them.

New Business:

- Moland Township contacted Fred regarding the stretch of road located on 15th Ave N. between County Rd 19 and 120th St. N. This section of road wasn't mowed this October. Fred and Kevin looked up the stretch of road and realized the township hadn't contracted the mowing of this section of road. Fred will call Moland to let them know we will get this mowed.
- The township received a letter from the County regarding the election judge training schedule. Justin reached out to Mary Jane (election judge) who checked with the others to make sure they were current with their training. All judges are up to date with their training. No further action needed.
- The township received a letter from the County regarding the annexation of a part of Moorhead township to Dilworth. The resolution was adopted by the City on August 24th and the Township on August 21st.
- Justin had contacted the Township lawyer regarding the township's ability to control the farming of cannabis. Maddie Cash followed up the conversation with an email regarding this discussion. It was established, the township can adopt reasonable restrictions to the time, place, and manner of the operation of cannabis business provided that such restrictions do not prohibit the establishment of operation of cannabis business.
