JULY 8th 2025, MONTHLY MEETING
GLYNDON COMMUNITY CENTER

Meeting Minutes:

Members present were Fred Kuehl, John Winter, Fred Dorsett, Angie Kuehl, and Justin Thompson. Fred called the meeting to order at 7:08PM.

The minutes from June's meeting were reviewed. John made a motion to accept these minutes. Fred seconded the motion. The minutes were accepted and signed.

The Treasurer's Reports (Balance Sheet and Profit Loss YTD Comparison) were reviewed and signed by the present supervisors. Fred made a motion to accept the treasurer's reports. John seconded the motion. The motion passed

Old Business:

- Federal Land Trust on the property West of HWY 336.
 - It was discussed that if a casino was going to be constructed on the property, the state would not allow them to improve Highway 336. It was understood that other government entities would have to build an overpass on Interstate 94 which would have direct access to the casino.
 - No further business was discussed. The topic was tabled until next month.

New Business:

- Cindy Thormodson Pool Permit
 - Cindy joined the meeting and described the pool they intend to install on their property. Fred made a motion to allow the 27' diameter pool installation. Ed seconded the motion. The motion passed and was signed.
- Fire Department funding.
 - The fire department held a meeting to inform the City and Townships that they will not be looking for additional funding this year. However, in 2027 the cost is slated to triple for Glyndon township (to approximately \$14,200 plus \$7,000)
 - Justin Vogal is slated to join the August meeting to discuss the number of trucks.
 - The fire department will continue to apply for grants to help offset the costs.
- Quickbooks Accounting software.
 - Angie brought up our quickbooks account. We had previously been paying a yearly fee to download the latest version of Quickbook's. However, Quickbooks has since moved to a monthly subscription fee structure, which is significantly cheaper than the downloaded version. The board agreed this is the better way to track our revenue. Fred made a motion to approve the use of the subscription based quickbooks. John seconded the motion. The motion passed.
- Moorhead Wellhead Protection Plan
 - Fred (Chairman of Glyndon Township) received a letter from Moorhead Public Service on June 20th. The purpose of the letter was to inform the townships that they plan to amend and update its Wellhead Protection Plan (WHPP). The entire process will take approximately two years to complete. There will be a public

information meeting in the summer / fall of this year. We are to report any items to the Water Plant Manager.

- The board briefly discussed if there were any items to report. None were thought of, no further actions were taken.
- Gopher Bounty
 - Nolan Faber collected 25 pocket gophers and turned in their legs for his bounty. Fred made a motion to approve the payment for the 25 gophers. John seconded the motion. The check was written to Nolan.
